## DIRECTIONS FOR COMPLETING TRANSFERS OF OWNERSHIP

1. Write in name, address & phone # of the buyer.
2. Fill in the name and R.H.B.A.A. Reg. number of the horse to be transferred.
3. Write in the date of delivery; that is, the date on which the animal was handed over to the buyer.
4. The seller must personally sign his name & SS number in the space for that purpose and provide his address.
5. If the horse to be transferred is a mare and has been served before being turned over to the new owner, the name and R.H.B.A.A. Reg. number of the Stallion and the date the service took place must be given; the owner of the Stallion must personally sign his name on the line designated and indicate whether service fee has been paid. Foal cannot be registered until service fee is paid.
6. If the horse to be transferred is a mare and has not been served, the words "Not Served" must be written in the space for service.
7. Transfer papers having erasures - that is, names of horses, dates or signatures scratched out and rewritten - are not acceptable. If a mistake is made, use a fresh blank.
8. All writing must be typed or printed in ink. Do not use lead pencil.
9. Remit money to meet fees when sending transfers for record.
